1.6 Executive Updates

President

Things are going super well so far at the SFUO and we've had a busy first month and a half!

Shortly after our respective mandates, the main SFUO offices we're temporarily moved for renovations.

Our current offices are located at UCU 102.

Over the last few years, particularly with the adoption of the u-pass, the traffic flow at the SFUO reception has increased significantly. It was now time to look at our front reception area and find solutions to improve the service for members.

In mid-May, the executive went on an executive retreat. We came up with a few goals for the year to come. We will have another retreat in the near future to establish our priorities for the academic year, and present them to the board in the form of a report later in the summer.

As many of you may have already noticed, the SFUO attracted a lot of media attention over the last few weeks, particularly around the issue of Tuition Fees.

To sum up the events quickly, the On Friday May 24th, Allan Rock had meeting with both the SFUO and the GSAÉD informing us that he intended on proposing a tuition fee

increase of 3% per year for the next four years. The vote was too take place Monday May 27th. Over the following weekend, students mobilized over social media, some of you may have noticed the many Facebook photos that were posted around that time. These actions along with a press released that we published on the day of the vote attracted a lot of media attention. Thanks to the efforts of students in mobilizing around this issue, Allan Rock informed us at 5:10pm, 20 minutes for the BOG vote on a tuition fees that he was changing his mind, and only proposing a tuition fee increase for one year. Despite this, a this point, any increase is a problem and students decided to serve Kraft Dinner to Board members, before shutting down the meeting. Despite the fact that students we're incredibly vocal and clear with their message "No increase", we heard last week that the BOG passed the vote to increase our tuition fees, 3% for undergrads domestic; 10% for international students, and 5% for grad students.

The vote finally took place on June 21st* over via e-mail. Student governors expressed concerns with the process, and did not agree to voting online. Furthermore, a student governor presented an amendment which was not pass around to the Board of Governors, nor discussed before the tuition fee vote passed.

Everyone at the SFUO is not only planning the year ahead, but also focusing on 101 week which is fast approaching. I won't give away too any scoops! I'll let Pat Marquis give you all the details.

In relation to 101 week, I am currently getting a team of Safety Ambassadors together. The interview process for selecting Safety Ambassador is ongoing, and I am planning the necessary training that needs to take place before the end of summer.

As an executive, this year we've decided to have a welcome back event on September 13th. This will be a event at which all students will be invited! Details to come soon.

From May 3rd to May 5th, I went, with the Bilingualism centre, to the general assembly of the Regroupement étudiant franco-ontarien (RÉFO). We've had very constructive discussions around the barriers that francophone students face on our campuses. We also discussed the General Town halls which will take place in February, preceded by a provincial tour and discussions with francophone students from every corner of the province.

Last year, the francophone gala was a great success. This year, I have started working on the gala much sooner with the hope of getting new partners and having a bigger event. I am also working with the Gee-Gees, sports services and the Quidditch team. At the end of May, I attended the National General Assembly of the Canadian Federation of Students, during which I was elected Francophone representative on the national executive. Additionally to this, I attended the Skills Symposium put on by the Canadian Federation of Students-Ontario in Mississauga. It was a great success. Finally, I must inform the board of any courses I am taking during my mandate. During the first half of the summer, I took Women and the Media, CMN 3104.

- Working on a Pow Wow for 101 week with the Sustainability Centre, the Sociology and Anthropology Students Association and the Indigenous and Canadian Studies Students Association
- The Pride Centre has revamped their Ally Training for the upcoming Guide trainings
- IHouse will be organising a series of summer events, including a soccer tournament and a series of international meals.
- The Centre for Students with Disabilities has almost completed their accessibility consultations with the VP Socials of ever Fed Body for their 101 weeks.
- The Clubs Department is undergoing a series of changes, including renovations to the Clubs Room
- Attended the Canadian Federation of Students Aboriginal Caucus Standalone meeting and had the chance to work with Indigenous students from across the country
- Attended the Canadian Federation of Students Annual General Meeting; was elected as Commissioner for the Queer students constituency group
- Attended the Skills Symposium, organised by the Canadian Federation of Students Ontario chapter

VP University Affairs

Advocacy and Governance

- Services
 - The two services are very busy at the beginning of the summer because students now have more time to pursue appeals and seek help.
 - At the Centre for Equity and Human Rights we have hired two new employees. This is very helpful since they have been waiting to have those positions filled.
 - Working on a review of the university's Accessibility and Accommodation policies, in preparation for a stakeholder meeting in September.
- Campaigns Department
 - Going through a restructuring as part of the summer planning. This includes creation of a mandate, a new volunteer structure as well as looking at how priorities are set, and how the department can support the rest of the organization in the work that is done
 - Executive and the department meeting regularly to discuss advocacy work and how to outreach to students.
 - Stop the Hikes BBQ planned for next Wednesday which will be free in front of FSS. Hear students on these issues, answer questions and feed people

External Relations

- Union and Community Relations
 - Working with other student's unions in the city to challenge the student pass age cap
 - Become part of a working group on international students' issues with others from the CFS Ontario Executive Committee.
- U-Pass
 - The Coordinator is now a full time employee and we have the U-Pass Assistant working full time during the summer which helps provide more capacity as we prepare for distribution.
 - We have had regular meetings with university computer programmers to improve our process.
 - We will be introducing some brand new systems this year to make the U-Pass distribution smoother and give students more options.
 - We are also set to have the U-Pass co branded with the ISIC once again.

VP Services and Communications

- The agenda for the 2013-2014 academic year has been designed and ordered through the Canadian Federation of Students.
- I am currently working on the design and content of the mail out that is going to be sent out to all first year students coming to the University of Ottawa
- Planning of 101 week has begun and, in case you have yet to see the new logo for this year's theme, Vision, check out our Facebook page.

- I also participated in the AGM of the Canadian Federation of Students as well as the 2013 Skills Symposium, which took place over the month of June.
- My new position is also comprised of 5 of the 12 student services.
 - Peer Help is developing a new chat function for the Peer Help Support Phoneline which will be accessible through the Peer Help website. There will also be a BBQ during 101 week to promote the services that we are currently planning.
 - The Bike Coop is planning tune ups around the city and has been very busy as usual during the summer semesters. New bike repair stations are going to be set up around campus very soon so keep an eye out!
 - The Sustainable Development Centre is planning a Pow wow with a few partners as well as a farmers market during 101 week.
 - Food Bank is looking into developing some new campaigns revolved around the use of the food bank as well as eliminating the stigma around it's users and is also working on acquiring more food for students
 - Foot Patrol is expanding their bus riders program to include STO buses and more OC
 Transpo buses as well
- Furthermore, all the services are currently working on their promotion strategies for the year and so I'm in consultations with them and the marketing department on those.
- I, along with Nicole, went on a services retreat with the coordinators of the services for a couple of days of skill sharing, discussion regarding volunteers, promotion, how to better serve our members, and general ideas of projects to work on throughout the year.
- Zoom is working on a video for our new 101 week website which will be online soon. This video will show the different events and initiatives of the Student Federation throughout the year as well as introduce 101 week to new students.
- I've also created a bank of volunteer translators that will help translate materials for federated bodies when requested.
- First CRT was held earlier this month and the next one is in a couple of weeks.
- Lastly, our new webmaster has been working tirelessly on updating and creating new websites as needed.

VP Social Affairs

101 Week is going well. Committees have been started to discuss large events such as Fedstock, Camp Fortune (Named Gotham City Throwdown this year), the SFUO 101 Week, and Shine day. This year, alt 101 week is not happening as usual, so the SFUO will take the role to host the more accessible week for students. The week will be \$40 and alcohol free. Social Round tables are going very well, they have been bi-weekly since the start of May and will be weekly in July-August. Guide training has started, its going very well.

In terms of our philanthropic activities, Shinerama has already started and raised a significant amount. Federated Bodies are contributing a lot. We are also starting a new initiative called Gee-Gees for awesome. It is a week where it is highly encouraged to raise awareness and fundraise for the charity of your choice. Any group of friends, club, team, or association can participate and choose their own charity of preference. It can also be done individually and we encourage faculty, administration and other university staff to participate.

In terms of plan for the year, we plan on having another TEDxUOttawa, and a Friday the 13th event on September 13th that will serve as a back to school event for all incoming students and not just first years. We will also host various concerts throughout the year, speaker events and more. Party offs will happen again this year at 1848, which will bring more business on Thursday nights. Winter challenge is scheduled to happen again and same with end of year bash, volunteer gala and leader action. Will try to set up a "semaine de la poutine" which will be like ribfest (have various poutine stands throughout campus).
